## TS410 SAP Certification

(SAP Certified Application Associate – Business Process Integration with SAP S/4HANA) (10 full days: 9<sup>th</sup> to the 22<sup>nd</sup> January 2020)

through attending the Department of Information Systems' next TS410 course in conjunction with SAP University Alliances (SAP UA). This course /certification is an upgrade to what used to be known as TERP10.

**Cost:** (includes course manual + certification exam).

Course fees are designed to merely cover costs.

## Course description:

The course covers the fundamental integrative business processes in procurement, production planning, sales, project management, asset management, financial & management accounting and human resources within the SAP ERP application. Participants will be exposed to sufficient knowledge of the core organisation's processes, their integration as well as how they are supported by SAP S/4HANA systems. At the end of the course, participants will sit for a SAP Certification examination and those who will successfully pass will receive the TS410 SAP Certification.

The typical audience for the TS410 course includes students as well as professionals in fields such as Application Consultant, Business Analyst, Business Process Owner, Team Lead, Power User, Program/Project Manager as well as those starting the journey to becoming SAP Consultants.

Requirements for course enrolment: You need to be currently registered as a student or academic at a recognized tertiary institution or have graduated within the last 3 months. You also need to have satisfactory prerequisite SAP/ERP knowledge such as passing an Information Systems course which covers integrated ERP concepts; or have evidence of practical SAP experience; or have completed ES Fundamentals for Business course. *Please note: this course is limited to 25 participants, early enrolment is advised.*
